Mr. Apostolos Tzitzikostas is the European Commissioner for Sustainable Transport and Tourism. His task is to make European transport more competitive, sustainable and resistant to future shocks and to ensure that it is safe, accessible and affordable for all EU citizens.

He is responsible for:

- Advancing sustainable aviation, in particular by supporting the deployment and uptake of Sustainable Aviation Fuels across the EU and beyond;
- Working with Member States and stakeholders to improve air traffic management in Europe, with the aim of overcoming inefficiencies and fragmentation through progress on the Single European Sky;
- Ensuring the completion of the Trans-European Transport Network, strengthening cross-border connectivity, European cohesion and resilience;
- Putting forward and implementing a Sustainable Transport Investment Plan to prioritise and scale up investments needed to modernise and decarbonise the transport system;
- Strengthening the single market for transport services, enhancing competitiveness and removing remaining barriers;
- Developing strategies for key transport sectors, including maritime transport and ports, with a focus on sustainability, security and competitiveness;
- Promoting a resilient and competitive tourism sector, in line with the EU Agenda for Tourism 2030;
- Putting forward and implementing a plan for an ambitious European high-speed rail network, improving connections between EU capitals and large cities.

In his current role, he builds on his extensive background as Governor of Central Macedonia (2013-2024), President of the Association of Greek Regions (2019-present) and President of the European Committee of the Regions (2020-2022).

A Greek politician from Nea Demokratia, he previously served in the Greek Parliament and holds a Bachelor's degree in Political Science and International Politics from Georgetown University and a Master's degree in European Public Policy from University College London.

His Excellency Eng. Saleh bin Nasser Al Jasser is the Minister of Transport and Logistic Services of the Kingdom of Saudi Arabia. He has been appointed by a Royal Decree on 23 October 2019.

He chairs the boards of several leading authorities and companies, including the General Authority of Civil Aviation, the Saudi Ports Authority, the Transport General Authority, the Saudi Railways Company (SAR), and the Saudi Arabian Airlines Corporation. He also serves as Vice-Chairman of the Executive Committee of the National Industry and Logistics Development Program, and chairs both the Saudi-Jordanian Joint Committee and the Transport and Border Ports Committee of the Saudi-Iraqi Coordination Council.

With over 30 years of experience in business administration and leadership, His Excellency previously served as Director-General of Saudi Arabian Airlines, CEO of Bahri, and held senior executive positions at Abdul Latif Jameel Group. He holds a Master's degree in Business Administration from King Saud University and a Bachelor's degree in Industrial Engineering from King Abdulaziz University, complemented by advanced executive programs at Harvard, Oxford, INSEAD, and other prestigious institutions.

Honourable Viliame 'Bill' Gavoka is the current Deputy Prime Minister and Minister for Tourism and Civil Aviation. Honourable Gavoka has over 30 years of illustrious experience in the tourism and travel industry. He has held several executive positions, including Thomas Cook, Shangri-La's Fijian Resort and Spa, Fiji Mocambo, Amunuca Island Resort and Spa and Fiji Visitors Bureau (now Tourism Fiji) as Chief Executive Officer.

He has held several Chairmanship and Board positions on businesses and statutory organisations, including Fijian Holdings Limited, Fiji TV and Media Niugini Ltd, South Sea Cruises/Blue Lagoon Cruises, Fiji Rugby Union, South Pacific Tourism Organisation, Fiji Hotel Association, Pacific Area Travel Association, Society of Fiji Travel Associates, Fiji Trade and Investment Board, Civil Aviation Authority of Fiji and Air Terminal Services.

Earlier in his career, he was trained in librarianship and then went into banking with Citicorp of New York, serving in its Fiji operations. He served for two years with the Territorial Forces of the Republic of Fiji Military Forces. Honourable Gavoka first successfully contested the 2014 General Elections under the SODELPA banner and has been a Member of Parliament since. During his time as an Opposition

financial crisis following the 9.11 attacks. Mr. Walsh led a radical restructuring that returned Aer Lingus to profitability.

In 2005, Mr. Walsh was appointed chief executive of British Airways (BA). He led BA through the 2008/09 Global Financial Crisis, established a transatlantic joint business venture with Iberia, Finnair and American Airlines, and oversaw the 2011 merger of BA and Iberia under a newly established parent company, International Airlines Group (IAG). Mr. Walsh served as chief executive of IAG from its inception until he retired in September 2020.

At IATA, Mr. Walsh will work from the association's main offices in Montreal, Canada and Geneva, Switzerland. A citizen of Ireland, Mr. Walsh holds a Master of Science and Business Administration from Trinity College, Dublin.

Mr. Simon Hocquard has over 30 years' experience across the air traffic management industry and is accountable for leading and managing CANSO – the global voice of airspace. He leads the team responsible for delivering on all CANSO's commitments to its members and the wider industry at large, and raising the bar in global air traffic management.

Mr. Hocquard's previous roles have included Operations Director at NATS, where he led 1,500 people through the successful air traffic management for the 2012 London Olympics and other change programmes; Operations and Strategy Director at NATS, where he was also accountable for the entire regulated business; appointed by the European Commission as Chairman of the Network Management Board for 10 years where he worked very closely with governments and international institutions to ensure the expeditious transit of flights in Europe.

He is also Chair of the Complete Air Traffic System (CATS) Global Council, an independent forum that facilitates collaboration among leaders from across the aviation & aerospace industries, and helped build a unified vision for the future skies.

Mr. Patrick Ky is the Chief Executive Officer of the International Centre for Aviation Innovation (ICAI), based in Singapore. ICAI functions as an international hub to unite governments, industry stakeholders, and research institutions in addressing key aviation challenges and co-developing innovative solutions for the future of air travel.

Before taking the helm at ICAI, Mr. Ky served for a decade as Executive Director of the European Union Aviation Safety Agency (EASA), where he expanded the agency's global influence and led major initiatives to enhance aviation safety standards.

Under his leadership, EASA established tougher certification requirements for the Boeing 777X, oversaw the safe ungrounding of the 737 MAX, and mandated critical fire protection improvements for the Airbus A321XLR. He also spearheaded global regulatory efforts for the emerging advanced air mobility sector and artificial intelligence.

Beyond regulatory advancements, Mr. Ky guided EASA through five major aviation crises - the shooting down of Malaysia Airlines Flight

17, the Germanwings crash, the Boeing 737 MAX crisis, the COVID-19 pandemic, and the Russia-Ukraine war, ensuring the agency adapted swiftly to new realities with flexible policies and strengthened safety measures.

Earlier in his career, Mr. Ky led Europe's air traffic management modernisation as head of the SESAR programme.

His contributions to aviation have earned him numerous accolades, including The Glen A. Gilbert Memorial Award in 2013 and the title of "Industry Leader of the Year" by Germany's *Fliegermagazin* in 2015. In 2025, Mr. Ky was honoured with the Philip J. Klass Lifetime Achievement Award for his lasting contributions to aviation safety.

Mr. Ky is a graduate of École Polytechnique and the Civil Aviation Engineering School in France. He also holds degrees in economics from the University of Toulouse and the Massachusetts Institute of Technology.

**Mr. Bryan Bedford**

Mr. Bryan Bedford was sworn in as FAA Administrator in July 2025. He leads a workforce of more than 40,000 employees dedicated to the FAA's mission to provide the safe and efficient operation of the largest and most complex aerospace system in the world. An aviation industry veteran for more than 35 years, Mr. Bedford has a proven track record of safe operations, executive leadership and innovation.

Mr. Bedford previously served as president and chief executive officer of Republic Airways. During his 26 years at the helm of Republic, the airline grew from \$85 million in revenues and 36 turboprop aircraft to more than \$3 billion in revenues and an operating fleet of more than 250 jets, while maintaining a perfect passenger safety record.

In 2018, Mr. Bedford led Republic in launching the visionary LIFT Academy, the first airline-owned training academy. As the cutting-edge program began to equip pilots with the skills they need to succeed, LIFT added an aviation maintenance training program.

Mr. Bedford's previous jobs include president and chief executive of Mesaba Airlines, president and chief executive officer of Business Express Airlines, chief financial officer of Phoenix Airline Services, and chief financial officer for West Air Airlines. Mr. Bedford has served as chairman of the Regional Airline Association for multiple terms.

He was named Airline Executive of the Year in 1997, 2004, and 2009, and holds a multi-engine, instrument-rated private pilot license. Mr. Bedford graduated from Florida State University with a bachelor's degree in finance and accounting.
